The Child & Adolescent Needs and Strengths (CANS) is a multisystem assessment tool designed for communication and planning among families and the Children Service System partners.

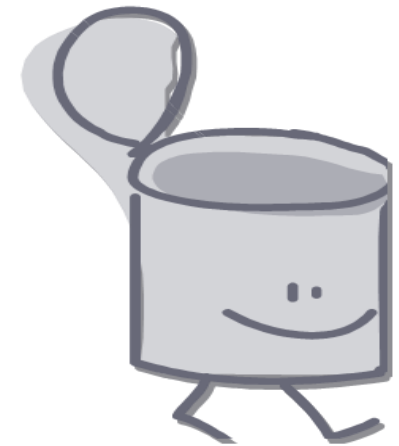

Certification in the CANS instrument is only valid for one year; recertification is required annually.

This training opportunity is open to individuals whose certification has expired or is expected to expire within six months.
